### Item 2.02 Results of Operations and Financial Condition

On January 13, 2025, Ekso Bionics Holdings, Inc. (the "Company") issued a press release (the "Press Release") announcing certain preliminary financial results for the fourth quarter 2024. The full text of the Press Release announcing such results is attached as Exhibit 99.1 to this Current Report on Form 8-K and is incorporated herein by reference.

### Item 8.01 Other Events

In the Press Release, the Company reports the following preliminary financial results:

- Total revenue for the fourth quarter of 2024 is estimated to be in the range of \$5.0 million to \$5.1 million, which is expected to be a Company record, compared to total revenue of \$4.8 million for the fourth quarter of 2023.
- Estimated cash as of December 31, 2024 was \$6.5 million, compared to cash of \$8.6 million as of December 31, 2023.
- For the fourth quarter of 2024, the Company used an estimated \$1.5 million of net cash in operations, compared to \$1.6 million for the same period in 2023.

The estimated, projected or anticipated financial results, financial condition or other financial information discussed in this Current Report on Form 8-K are based on management's preliminary unaudited analysis of financial results for the quarter ended December 31, 2024. ## Ekso Bionics Reports Certain Preliminary Fourth Quarter 2024 Financial Results

Expects Record Revenues for the Fourth Quarter of 2024

SAN RAFAEL, Calif., January 13, 2025 -- Ekso Bionics Holdings, Inc. (Nasdaq: EKSO) (the "Company"), an industry leader in exoskeleton technology for medical and industrial use, today announced preliminary top line financial results for the quarter ended December 31, 2024.

Total revenue for the fourth quarter of 2024 is estimated to be in the range of \$5.0 million to \$5.1 million, which is expected to be a Company record, compared to total revenue of \$4.8 million in the fourth quarter of 2023.

"We made significant progress in 2024, highlighted by initial CMS reimbursement for our Ekso Indego Personal," said Scott Davis, the Company's Chief Executive Officer. "With expanded access of this transformative device to Medicare-covered patients, we remain focused on building upon our growing CMS claim pipeline. At the same time, we continue to bolster demand for our flagship EksoNR device as we execute on our long-term growth strategy."

Estimated cash as of December 31, 2024 was \$6.5 million, compared to cash of \$8.6 million at December 31, 2023. For the fourth quarter of 2024, the Company used an estimated \$1.5 million of net cash in operations, compared to \$1.6 million for the same period in 2023.
