The RSUs vest in twelve equal installments on the first twelve monthly anniversaries of the Effective Date, starting February 21, 2022, such that the RSUs will be fully vested as of January 21, 2023. The tenth installment of RSUs vested on November 21, 2022 and were delivered to the Reporting Person upon settlement.
